<sup>3)</sup> NB: A fee of EUR 35 (DKK260 / MYR165) shall be charged for countries where the European Commission has concluded, or is negotiating a visa facilitation agreement.

<sup>4)</sup> No fee shall be charged for applications regarding the naturalisation of children below the age of 18 provided the parents - or one of these - were born Danish or have subsequently obtained Danish nationality.

<sup>5)</sup> Where several documents are issued at the same time, a total fee of DKK 200 / MYR130 shall be charged.

<sup>6)</sup> Provided the request for VAT refund comprises several separate purchases, a fee of DKK200 / MYR130 shall be charged per statement.

<sup>7)</sup> Where several provisional passports or extension of passports are issued at the same time, a fee of DKK2,265 / MYR1,460 shall be charged for the first passport and DKK970 / MYR625 for subsequent passports.

<sup>8)</sup> Where several provisional passports or extension of passports are issued at the same time, a fee of DKK3,240 / MYR2,085 shall be charged for the first passport and DKK970 / MYR625 for subsequent passports.
