<sup>2)</sup> If case processing is required, an hourly rate or part thereof will be charged.

<sup>3)</sup> NB: A fee of EUR 35 (DKK 260)/(MYR170) shall be charged for countries where the European Commission has concluded, or is negotiating a visa facilitation agreement.

<sup>4)</sup> No fee shall be charged for applications regarding the naturalisation of children below the age of 18 provided the parents - or one of these - were born Danish or have subsequently obtained Danish nationality.

<sup>5)</sup> Where several documents are issued at the same time, a total fee of DKK 195/MYR130 shall be charged.

<sup>6)</sup> Provided the request for VAT refund comprises several separate purchases, a fee of DKK 195/MYR130 shall be charged per statement.

<sup>7)</sup> Where several provisional passports or extension of passports are issued at the same time, a fee of DKK 2,150/MYR1,425 shall be charged for the first passport and DKK 955/MYR635 for subsequent passports.

<sup>8)</sup> Where several provisional passports or extension of passports are issued at the same time, a fee of DKK 3,075/MYR2,040 shall be charged for the first passport and DKK 955/MYR635 for subsequent passports.
