⁴⁾ No fee shall be charged for applications regarding the naturalisation of children below the age of 18 provided the parents - or one of these - were born Danish or have subsequently obtained Danish nationality.

⁵⁾ Where several documents are issued at the same time, a total fee of DKK 200 / MYR135 shall be charged.

⁶⁾ Provided the request for VAT refund comprises several separate purchases, a fee of DKK200 / MYR135 shall be charged per statement.

⁷⁾ Where several provisional passports or extension of passports are issued at the same time, a fee of DKK2,355 / MYR1,580 shall be charged for the first passport and DKK1,010 / MYR675 for subsequent passports.

⁸⁾ Where several provisional passports or extension of passports are issued at the same time, a fee of DKK3,365 / MYR2,255 shall be charged for the first passport and DKK1,010 / MYR675 for subsequent passports.
